Completion of Acquisition of Aircraft Asset by Aircraft Investment Fund

MACH 1, the aircraft investment fund, in which Airport Facilities Co., Ltd. ("AFC") is engaged as an anchor investor and operated by Mercuria Investment Co., Ltd. ("MIC"), the core company of Mercuria Holdings Co., Ltd., as a part of its aircraft investment strategy, has purchased its first aircraft.

[About Airbus A320ceo]

The newly acquired aircraft asset is an Airbus A320ceo. The Airbus A320ceo Family, the first series of narrowbody jets developed by Airbus SE consisting of the standard A320, the bigger A321, and the smaller A319, are mainly used as short-to-medium range commercial airliners. According to Airbus, A320ceo is one of the most frequently used jet airliners in the world, with approximately 4,300 units operated by approximately 250 airlines in various countries. The aircraft purchased by MACH 1, which has been used by major European carriers on long-term lease contracts, is expected to generate stable cash flows.

[External Environment, and Increasing Use of Leased Aircraft]

As the world economy continues to expand, crossborder movement has become the trend of the times, and the rise in demand for travel, as well as for new aircraft, is projected to continue for the foreseeable future. With the existing demand for fleet replacement, more and more aircraft are expected to be introduced into the market in coming years. However, it is very costly for airlines to purchase all the airliners required for their operations. Also, in order to respond to rapid changes in the external environment, airlines are leaning towards using leased aircraft. The percentage of leased aircraft as of 2022

accounts for approximately 50%. The dependence on leased aircraft is likely to continue.

[MACH 1's Investment Strategy]

MACH 1's predecessor fund formed by MIC in 2017 is still in operation. This aircraft investment fund experienced the unprecedented impact on the aviation industry caused by the coronavirus pandemic. We acquired valuable know-how while coping with the difficult times and continuing our aircraft investments. Now that MACH 1 has been launched, we will work closely with Airborne Capital Limited ("ACL"), our strategic partner headquartered in Ireland, to make the right choices in selecting aircraft assets that can achieve stable returns, and execute appropriate investments by making sound judgment about the creditworthiness of lessee airlines. ACL, the manager of approximately 60 aircraft assets, has made many noteworthy achievements through its aircraft-related advisory services.
